Ana Sofia Rodrigues, Member of the Board of the Portuguese Competition Authority



Ana Sofia Rodrigues was appointed Member of the Board of the Portuguese Competition Authority – AdC in April 2023.

Since October 2015 she was Chief Economist and Head of the AdC's Economic Studies and Market Monitoring Office, after a year as a senior competition expert in the Competition Division of the Organization for Economic Cooperation and Development (OECD) in Paris.

Before that she held various positions at the Portuguese Competition Authority, where she started her career in Competition Policy in 2006; she was a senior economist at the Merger Department and at the Bureau of Economic Studies and Market Monitoring, and more recently, she was an economic advisor to the Board.

Ana Sofia was the President of ACE – the Association of Competition Economics, an international network of competition economics, from January 2020 to December 2022.

She holds a PhD in Economics from the Department of Economics of the University of York (2008), where she also completed the M.Sc. in Economics in 2002. She was a teaching fellow at the University of York, and she was also a visiting research scholar at the *Lebow College of Business*, Drexel University, Philadelphia. She did her undergraduate studies in Economics at the Faculty of Economics of the University of Coimbra (2000).

António Costa Silva, Minister for the Economy and the Sea



He has a degree in Mining Engineering from the Lisbon University Higher Technical Institute, a master's degree in petroleum from Imperial College (University of London), a PhD in Petrol Reserve Engineering from Lisbon University Higher Technical Institute and Imperial College.

He is professor emeritus at the Lisbon University Higher Technical Institute, where he also taught Planning and Integrated Management of Energy Resources.

Upon invitation of the Portuguese Government, in 2020 he drafted the Strategic Vision for Portugal's Economic Recovery Plan for 2020-2030 and presided over the National Steering Committee for the Recovery and Resilience Programme since May 2021.

Chairman of the Partex Executive Committee from 2004 to 2021.

He was Director of Reservoir Engineering and Production at Beicip-Franlab, the corporate branch of the French Petroleum Institute (Paris, 2001-2003) and Executive Director of the Compagnie Général de Geophysique in Portugal (1998-2001). He began his professional career at Sonangol (Angola) in 1980, and from 1984 to 1997 he worked at the Portuguese Service Company.

Throughout his career, he was charged with coordinating several international energy projects, particularly the Middle East, Algeria, Mexico, Venezuela, Russia, Iran, Saudi Arabia, Brazil, and Angola.

He was selected in 2002 by the International Court of the Stockholm Chamber of Commerce as the expert charged with solving the legal and technical dispute between two of the major oil companies in the world in an oil rig on the China sea. Since 2018, he has been a member of the Board of Trustees of Aveiro University; he was also Chairman of the Fuel Board of the regulator - ERSE, member of the Calouste Gulbenkian Foundation Advisory Board and Chairman of the Water Initiative Advisory Board at Católica University in Lisbon.

He was member of the ISCTE- Lisbon University Institute Board of Trustees and the Advisory Board of the Gulbenkian Programme for Development Aid.

He was a guest speaker at international conferences on energy, energy and geopolitics, and has published several articles and papers in the fields of energy, strategy, geopolitics, and international relations.

António Ferreira Gomes, Deputy Director of the OECD Directorate for Financial and Enterprise Affairs – OECD



Antonio Gomes is Deputy Director of the OECD Directorate for Financial and Enterprise Affairs, the Directorate responsible for the areas of Competition, Investment, Financial Markets, Consumer Finance, Insurance and Pensions, Anti-Corruption, Corporate Governance and Corporate Finance, and Responsible Business Conduct. He previously served as Head of the OECD Competition Division, President of the Portuguese Competition Authority, Senior Competition Expert at the OECD Competition Division and Director of the Merger Department of the Portuguese Competition Authority. Since 2005, he has been an Assistant Professor at the Universidade de Aveiro, Portugal. Antonio Gomes holds a PhD in Economics from the University of York, U.K., and Master Degrees in Economics from the University of York and the Universidade Nova de Lisboa.

Aviv Nevo, Director of the Bureau of Economics at the U.S. Federal Trade Commission



Aviv Nevo is the Director of the Bureau of Economics at the U.S. Federal Trade Commission. He is on leave from the University of Pennsylvania where he is the George A. Weiss and Lydia Bravo Weiss Penn Integrates Knowledge Professor with appointments in the Economics Department and the Wharton School. He served as the Deputy Assistant Attorney General for Economic Analysis at the Antitrust Division of the DOJ 2013-2014. His academic research focuses on empirical Industrial Organization, Marketing, Antitrust and Competition Economics, and Econometrics. His past work has focused on estimating the demand for consumer packaged goods and the implications for price competition, mergers, and marketing. He has also done research in the areas of health economics, health care, telecom, and real estate.

Cañi Fernández, President of the National Commission for Markets and Competition – CNMC



She has practiced and lectured EU and Competition Law since 1989. She was référendaire at the Court of Justice of the European Union. The first woman appointed as Co-Chair of the IBA Antitrust Committee, she also held the position of Vice-chair of the Economics Committee of the ABA Antitrust Section, Officer of the International Cartel Task Force of the ABA Antitrust Section, and member of the IBA LPD Council. She was also an NGA of the EU Commission and the CNMC before the ICN. Recognized year after year as one of the 30 best specialists in Competition/Antitrust

worldwide in the Best of the Best category of the Expert Guides. GCR recognized her as one of the "100 Women in Antitrust Worldwide". In 2018 and 2019 Chambers named her "Star Individual" in her specialty in Spain. She is the first woman awarded with the "Outstanding Contribution to the Legal Profession" by Chambers.

Catherine Batchelor, Director, Digital Markets Unit - UK Competition and Markets Authority



Catherine is a Director within the Digital Markets Unit at the UK Competition and Markets Authority, where she is responsible for leading work to prepare for the new pro-competition regime for digital markets. She previously led the Digital Markets Taskforce, providing advice to the UK Government on the design and implementation of pro-competition measures for digital markets, building on the proposals put forward by the Digital Competition Expert Panel, chaired by Jason Furman. Prior to joining the CMA, Catherine

worked at the Financial Conduct Authority, the UK's conduct regulator for financial services in a range of roles including considering competition and innovation within financial services, including a secondment to HM Treasury as Head of FinTech Strategy. Catherine holds a BSc in Economics as well as an MSc in the Economics of Regulation and Competition.

Cristina Caffarra, Economist and Competition Expert



Dr Cristina Caffarra is a globally renowned competition expert. She headed for 17 years the Competition Team of CRA in Europe and subsequently set up Keystone Europe in July 2022. She is now an independent expert, commentator and thought leader on the digital economy.

Cristina holds a Master and PhD in Economics from Oxford University and is an expert in the application of modern industrial economics to competition and regulation questions – with particular focus on digital

industries. She appeared as expert witness in multiple high-profile cases before the courts in several jurisdictions, and advised on the most high-profile landmark competition cases of the last 20 years before the EC and national agencies (across Europe as well as Australia, South Africa, the Middle East, South East Asia and the US) – on behalf of clients like Microsoft, Apple, Amazon, Uber, Liberty Global, Sky, Samsung, Visa and many others.

She is sought after as a public speaker and regularly presents at top events on competition, regulation and digital policy. She is also a convener with the ability to gather senior agency, policy and academic speakers for the most high-profile events in Europe on competition, regulation, and digital policy. She has written multiple contributions to the field of competition and regulation of digital markets, lectures in competition economics as an Honorary Professor at UCL, and is also Associate Fellow of the Centre for Economic and Policy Research (CEPR) in London and Deputy Director of the CEPR Competition Research Policy Network.

Elisabetta Iossa, Commissioner – Italian Antitrust Authority



Elisabetta Iossa is Commissioner at the Italian Antitrust Authority since 1st February 2022. She is full Professor of Economics at the University of Rome “Tor Vergata” (*on leave*), Research Fellow at the C.E.P.R.(London), GREEN-Bocconi, and member of the Executive Committee of the European Association for Research in Industrial Economics (E.A.R.I.E.). She obtained a Ph.D. in Economics at the University of Naples “Federico II”, an M.Sc. in Economics at the University of York, and a T.M.R. Marie Curie Post-doc European Fellowship at the Université Libre de

Bruxelles (E.C.A.R.E.S.). Her work experience includes Brunel University in West London (*Senior Lecturer, Full Professor*), Université Libre de Bruxelles (*suppléant*) and Université de Liege (*maitre de conferance*). She was visiting scholar at Bristol University, Catholic University of Milan, Harvard University and Toulouse School of Economics.

Her research is in the field of industrial economics, with a focus on competition policy and public procurement. Whilst in the academia, she has provided expert advice to various international institutions including European Commission, European Bank for Reconstruction and Development, UK Competition Authority, UK Financial Service Authority, Organization for Economic Co-operation and Development, Office of Fair Trading, IFAD-United Nations, Inter-American Development Bank, World Bank.

Francesco Decarolis, Professor of Economics at The University of Bocconi



Francesco Decarolis is Professor of Economics at Bocconi University in Milan. His research is Industrial Organization with a focus on topics in competition economics, antitrust, market design, public procurement and the regulation of digital platforms. He is a CEPR Research Affiliate, an associate editor of The Review of Economic Studies and Journal of the European Economic Association, a board member of the Association for Competition Economics and a member of the Executive Committee

of European Association for Research in Industrial Economics. He held various advisory roles for different public bodies including the European Commission, the Italian Presidency of the Council of Ministers, the Italian Antitrust Authority and the Milan Court of Justice. He is the recipient of two ERC Research Grants.

Frederic Jenny, Chairman, OECD Competition Commission



Frederic Jenny holds a Ph. D in Economics from Harvard University (1975), a Doctorate in Economics from the University of Paris (1977) and an MBA degree from ESSEC Business School (1966) He is professor of Economics at ESSEC Business School in Paris. He is Chairman of the OECD Competition Committee (since 1994), and Co-Director of the European Center for Law and Economics of ESSEC (since 2010). He was previously Non-Executive Director of the Office of Fair Trading in the United Kingdom

(2007-2014), Judge on the French Supreme Court (Cour de cassation, Economic Commercial and Financial Chamber) from 2004 to August 2012, Vice Chair of the French Competition Authority (1993-2004) and President of the WTO Working Group on Trade and Competition (1994-2003) He was visiting professor at Northwestern University Department of Economics in the United States (1978), Keio University Department of economics in Japan (1984), University of Cape Town Business School in South Africa (1991), Haifa University School of Law in Israel (2012). He was Visiting Professor at University College London Law School (2005-2010), Global Professor of Antitrust in the New York University School of Law's Hauser Global Law School (2014, 2017 and 2022) and Senior Fellow in the Online Global Competition and Consumer Law Master's Program, University of Melbourne (Australia) (2016-2018). Frederic Jenny has written extensively about trade, competition and economic development and has served as an adviser to many developing countries on competition and trade issues.

Giorgio Monti, Professor of Competition Law – Tilburg University



Giorgio Monti is Professor of Competition Law at Tilburg University and part-time professor at the Robert Schuman Center of the European University Institute in Florence, Italy. He is a Research Fellow at the Center for Regulation in Europe and one of the Editors of the *Common Market Law Review*, the oldest journal dedicated to European Union Law.

Gustavo Augusto Freitas de Lima, Commissioner - CADE's Tribunal



Gustavo Augusto is a Commissioner from the CADE's Tribunal. He has been a Federal Attorney since 2006 and was a legal adviser for two Brazilian Presidents in the field of Economic policies. Has a master's degree in Law and Public Policy, a Specialist degree in Public Law, and Bachelor's degrees in Law and Naval Sciences, with a major in Electronics. He also has courses at Harvard Law School and George Mason University.

Ioannis Lianos, President – HCC



Ioannis Lianos serves as President of the Hellenic Competition Commission since September 2019. Moreover, he is Professor, Chair of Global Competition Law and Public Policy and founding Director of the Centre for Law, Economics and Society at the Faculty of Laws, University College London. He has published extensively books and articles in various languages and leading academic journals. His most recent publications include *Global Food Value Chains and Competition Law*

(CUP, 2022), *Competition Law* (OUP, 2019), *Regulating Blockchain: Techno-Social and Legal Challenges* (OUP, 2019), *Reconciling Efficiency and Equity A Global Challenge for Competition Policy* (CUP, 2019), *Brands, Competition and IP Law* (CUP, 2015), *Damages Actions for Competition Law Infringements* (OUP, 2015), *Competition and the State* (SUP, 2014), the two volumes *Handbook in European Competition Law* (Edward Elgar, 2013), *Competition Law and Development* (SUP, 2013). He is co-editor of the *Journal of Competition Law and Economics*, published by Oxford University press, the co-director of the Cambridge book series on *Global Competition Law, Policy and Economics* and sits at the advisory board of a number of Research Institutes in the area of competition law and policy around the world, as well as at the advisory board of the *Journal of European Competition Law and Practice*. Mr. Lianos is also member of the executive committee of the *Academic Society of Competition Law (ASCOLA)*. Since 2021 he is a member of the Bureau of the OECD Competition Committee.

Jacques Crémer, Professor of Economics – Toulouse School of Economics



Jacques Crémer received his PhD from MIT in 1977 and has held appointments at the University of Pennsylvania and Virginia Tech University. Since 1991 he has been Professor at the Toulouse School of Economics, where he has held many administrative appointments, most recently being the first director of its Digital Centre. He is a Fellow of the Econometric Society and of the European Economic Association. He has done fundamental work on planning theory, auctions, incentive theory, organization economics, and more recently the digital economy. From April 2018 to March 2019, he was a Special Adviser to European Commissioner for Competition Margrethe Vestager, and in that capacity co-authored the report “Competition Policy for the Digital Era”. He is an active participant in the debates on the regulation of “Big Tech”.

John Newman, Deputy Director of the Federal Trade Commission’s Bureau of Competition



John Newman is currently serving as Deputy Director of the Federal Trade Commission’s Bureau of Competition. He is also a professor, on leave, at the University of Miami School of Law, and has served on the advisory boards of the American Antitrust Institute and the Institute for Consumer Antitrust Studies. He has published widely on antitrust law and policy for digital markets, and has been credited with coining the term “zero-price markets.” He began his legal career as a trial attorney with the U.S. Department of Justice Antitrust Division. While earning his law degree, he served as a research assistant to Professor Herb Hovenkamp.

Jorge Padilla, Senior Managing Director, Head of Compass Lexecon EMEA and Member of the Global Executive Committee



Dr. Jorge Padilla is Senior Managing Director, Head of Compass Lexecon EMEA and Member of the Global Executive Committee.

Dr. Padilla earned M. Phil and D. Phil degrees in Economics from the University of Oxford. He is Research Fellow at the Centro de Estudios Monetarios y Financieros (CEMFI, Madrid) and teaches competition economics at the Toulouse School of Economics (TSE).

He has given expert testimony before the competition authorities and courts of several EU member states, as well as in cases before the European Commission. Dr. Padilla has submitted written testimony to the European General Court, and the UK Competition Appeals Tribunal in cartel, merger control and abuse of dominance cases. He has also given expert testimony in various civil litigation (damages), international arbitration cases, and competition cases in non-EU jurisdictions (Argentina, Australia, Brazil, Canada, Chile, China, Colombia, India, Israel, Jamaica, Singapore, South Africa, Turkey, and the United States).

Dr. Padilla has written numerous papers on competition policy, industrial organization and finance in the *Antitrust Bulletin*, the *Antitrust Law Journal*, the *Economic Journal*, the *Energy Journal*, the *European Competition Journal*, the *European Competition Law Review*, the *Fordham International Law Journal*, *Industrial and Corporate Change*, the *International Journal of Industrial Organization*, the *Journal of Competition Law and Economics*, the *Journal of Economics and Management Strategy*, the *Journal of Industrial Economics*, the *Journal of Economic Theory*, the *RAND Journal of Economics*, the *Review of Financial Studies*, the *University of Chicago Law Review*, and *World Competition*.

He is also co-author of *The Law and Economics of Article 102 TFEU*, 3rd edition, Hart Publishing, 2020.

Lucia Bonova, Head of Unit, Digital Platforms, DG Competition - European Commission



Lucia Bonova heads a unit at the European Commission responsible for the implementation of Digital Markets Act and antitrust enforcement in the area of digital platforms. She holds a law degree from Université Panthéon-Assas in Paris and an LLM in International Business law from McGill University in Montreal. Lucia spent her entire professional career devoted to competition law enforcement, in particular merger control, and to a lesser extent, antitrust. Previously, she served in the private office of the Executive Vice-president of the European Commission for Competition and Europe fit for Digital Age, Margrethe Vestager. In addition to her experience at the European Commission, in 2009 Lucia spent three months at the Federal Trade Commission as an exchange official. Lucia was featured amongst 26 women at the forefront of global antitrust in GCR Women in Antitrust 2016: Enforcers and in 30 in their 30s Notable Women Competition Professionals in Enforcement in 2017.

Luís Cabral, Professor of Economics and Chair of the Economics Department – NYU Stern School of Business



Luís Cabral graduated from Stanford University (PhD, Economics, 1989) and is currently the Paganelli-Bull Professor of Economics and Chair of the Economics Department, both at NYU's Stern School of Business. His research interests include the dynamics of firm competition, both from the antitrust and strategy perspectives, and has a focus on the digital and entertainment industries. In addition to various journal articles, he is the author of Introduction to Industrial Organization, a textbook adopted by hundreds of universities worldwide; and Introduction to Microeconomics, an open-access textbook published in 2022.

Marc van der Woude, General Court of the European Union



Marc van der Woude is the president of the General Court of the European Union. He started his career as a tutor at the College of Europe in Bruges (1984-1986) and as a lecturer at Leiden University (1986-1987). He then joined the European institutions where he worked for DG Competition (1987-1989, 1992-1993), the European Court of Justice as a legal secretary (1989-1992) and the Commission's legal Service (1993-1995). He resigned from the European civil service to become a member of the Brussels bar, where he practiced

European and competition law for fifteen years (1995-2010). Marc van der Woude became a professor in competition law at the Erasmus University of Rotterdam (since 2000) and acted four years as an advisor on energy policy for the Dutch government (2002-2006). Marc van der Woude is an author of numerous publications on European and competition law and still teaches at Rotterdam University.

Massimiliano Kadar, Deputy Head of Unit A.1 at the Directorate General for Competition of the European Commission



Massimiliano Kadar is the Deputy Head of Unit A.1 at the Directorate General for Competition of the European Commission, in charge of antitrust policy and case coordination. Between 2011 and 2020, Massimiliano worked as case handler and manager on antitrust and merger control cases in a variety of sectors at the European Commission, and before then in private practice at Freshfields Bruckhaus Deringer LLP and Gianni Origoni Grippa Cappelli & Partners. He is a

visiting lecturer at Freie Universität Berlin a former visiting lecturer at King's College London. He has published several articles on competition policy, with a particular emphasis on Article 102 and merger control enforcement.

Miguel Moura e Silva, Member of the Board of the Portuguese Competition Authority



Born in Coimbra, he graduated in Law from the University of Lisbon Law School. It was also at this school that he obtained a Master's degree (EC Law), and a Ph.D. in Law — Legal and Economic Sciences. He also studied at Collège d'Europe and, as a Fulbright scholar and scholarship holder of the Ministry of Foreign Affairs, at the University of Michigan Law School.

Other positions include: Associate of the European Institute and the Institute for Economic, Financial and Tax Law of the University of Lisbon Law School; Senior Researcher at CIDEEFF – Research Centre on European, Economic, Financial and Tax Law, University of Lisbon Law School; Member of the Competition Law Scholars Forum; Elected member of the Law School Scientific Board; Member of the Scientific Advisory Board of the Competition and Regulation periodical; and Deputy Director of the Public Finance and Tax Law Review. Before joining the AdC Board, Miguel Moura e Silva practiced as a lawyer and was a member of The Association of Portuguese Competition Lawyers. He had been a staff member at the Portuguese Competition Authority as Director of the Restrictive Practices Department, Director of the Special Unit for Competition Assessment of Public Policies, and as Senior Legal Advisor. He was a former member of the Portuguese Competition Council and Director for International Relations of the Portuguese Rail Regulator. Since 1993, Miguel Moura e Silva is an Associate Professor of Law at the University of Lisbon Law School. He is also the author of several books and academic articles on Competition Law.

Mike Walker, Chief Economic Advisor – UK Competition and Markets Authority



Dr. Mike Walker is currently the Chief Economic Advisor at the UK Competition and Markets Authority. Previous to this, he was a Vice President at CRA International in London. He has worked on the economics of competition law and regulation for almost thirty years. He is the co-author of *The Economics of EU Competition Law* (Sweet & Maxwell, 3rd edition, 2009) and a number of published articles. He is a Professor at the College of Europe in Bruges and a Visiting Fellow at King's College, London.

Nuno Cunha Rodrigues, President of the Portuguese Competition Authority



With an academic career at the University of Lisbon School of Law (FDUL), where he graduated, obtained a master's degree in Legal and Business Sciences and a PhD in Legal and Economic Sciences, Nuno Cunha Rodrigues is president of the AdC since March 13, 2023.

As an associate professor at the mentioned Law School, he holds a Jean Monnet Chair, awarded in 2018 by the European Commission.

He has published books and scientific articles in Portugal and abroad, in Competition Law, European Union Law, Public Procurement, Economic Law, Public Finance and Tax Law, areas of expertise in which he lectures. Has been invited speaker by several national and international universities.

In 2022 was nominated for the "Antitrust Writing Awards", for the scientific article "Filling the Regulatory Gap to Address Foreign Subsidies: The EC's Search for a Level Playing Field Within the Internal Market".

Vice-President of the IDEFF - Instituto de Direito Económico, Financeiro e Fiscal and of the FDUL European Institute, he has been a member of the Advisory Board of the Journal of Competition and Regulation since its inception.

Before taking office at the AdC he was a lawyer and legal consultant, and held non-executive positions at Caixa Geral de Depósitos, Floene and OGMA - Indústria Aeronáutica de Portugal.

Olivier Guersent, Director-General of the Directorate General for Competition



Olivier Guersent is as of 1st January 2020 the Director-General of the Directorate General for Competition. He joined the European Commission in 1992, initially with the "Merger Task Force" in the Directorate-General for Competition. Since then, he has alternated between the private offices of a number of European Commissioners (Karel Van Miert, Michel Barnier and Neelie Kroes) and DG Competition (successively Deputy Head of Unit in charge of cartels, Head of Unit in charge of policy and coordination of cases, Head of Unit in charge of merger control, Acting Director "Transport, postal and other services" and, from 2009, Director responsible for the fight against cartels. From 2010 to 2014 he was the head of the private office of Michel Barnier, Commissioner for Internal Market and Services. Having held the position of Deputy Director-General since July 2014, Olivier Guersent has been Director-General of the Directorate-General for Financial Stability, Financial Services and Capital Markets Union from 1 September 2015 to 31 December 2019. He graduated with distinction from the "Institut d'Etudes Politiques de Bordeaux" in 1983. He joined the French Ministry of Economy and Finance in 1984, where he carried out many investigations for the French Competition Authority.

Pascale Déchamps, Deputy General Rapporteur – Autorité de la Concurrence



Pascale Déchamps is Deputy General Rapporteur at the French Competition Authority. She is the head of the unit in charge of antitrust infringement cases in the digital and telecom sectors, with a focus on online advertising. Her team has worked on major actions such as rejecting interim measures on Apple for its App Tracking Transparency system, fining Google €220 million for favoring its own services, the first commitments made by Meta to a competition authority in 2022 and imposing interim measures on Meta in ad verification in June 2023. Before joining the Authority in January 2021, Pascale was a partner at an economics and finance consultancy and was Head of their Paris office after being Head of their Brussels office for many years. She was also a non-governmental adviser to the Authority within the ICN between 2017 and 2020.

Penelope Papandropoulos, Head of the data analysis and technology unit of DG comp



Penelope Papandropoulos is currently head of the data analysis and technology unit of DG comp. Previously, she was member of cabinet of Executive Vice-President of the European Commission, Margrethe Vestager working on digital, energy, transport and media files in antitrust and mergers, as well as the Digital Markets Act. She also worked as the state aid coordinator at the Chief Economist team of DG COMP and as an economist on merger and antitrust cases. In 2014, she worked in the cabinet of Competition Commissioner Joaquín

Almunia, focusing on energy, transport, media and digital files. Prior to joining the Commission, she worked in the private sector as an economic consultant. In 2018-2019, she was the President of the Association of Competition Economists (ACE). She holds a PhD in economics from the University Libre de Bruxelles.

Patrick Rey, Professor of Economics - Toulouse School of Economics



Patrick Rey is a Professor of Economics at the Toulouse School of Economics; he has been the director of the Institut d'Economie Industrielle (IDEI) and, before joining Toulouse, he headed the Laboratoire d'Economie Industrielle (LEI) at CREST (INSEE, Paris), which he founded, and (what is now) the Ecole Nationale de la Statistique et de l'Administration Economique (ENSAE, Paris). He holds a PhD in Economics from the University of Toulouse, an engineer degree from Ecole

Polytechnique, where he has also been a professor, and a statistician-economist degree from ENSAE. His current themes of research include Industrial Organization, Regulation and Competition Policy, Innovation and Intellectual Property. He has published numerous papers and book contributions, including more than 50 articles in international top-tier economic journals such as *Econometrica*, the *American Economic Review*, the *Review of Economic Studies*, the *Journal of Political Economy* or the *RAND Journal of Economics*. He has also developed an innovative pedagogical tool using a "market game". Patrick Rey is a fellow of the *Econometric Society* as well as of the *European Economic Association (EEA)*, has been a senior member of the *Institut Universitaire de France (IUF)* and received a senior grant from the *European Research Council (ERC)*; he holds a *Honoris Causa* doctorate degree from the *Norwegian School of Economics (Bergen)* and has been President of the *European Association for Research in Industrial Economics (EARIE)*. He is widely recognized as a leading expert in competition economics. He has testified in many antitrust cases in Europe and elsewhere, conducted numerous competition workshops and seminars, and served as expert for OECD, the World Bank, the US department of Justice and the European Commission; he is also a member of the EAGCP (he coordinated for example the EAGCP expert group on Article 82 for the European Commission) and other advisory bodies attached to regulatory and competition agencies and he was a co-founder of the *Association for Competition Economics (ACE)*.
